

Lawn Mower Safety Warnings

A WARNING

Read all safety warnings, instructions, illustrations and specifications provided with this lawnmower. Failure to follow all instructions listed below may result in electric shock, fire and/or serious injury.

Save all warnings and instructions for future reference.

Work area safety

- To avoid bystander contact with the moving blade or a thrown object injury, keep the area of operation clear of all bystanders, particularly small children. Stop the lawnmower and any attachment(s) if anyone enters the area. Contact with the moving blade or thrown objects may result in serious personal injury or death.
- Only operate the lawnmower in daylight or good artificial light. Dark areas invite accidents.
- Do not operate lawnmowers in explosive atmospheres, such as in the presence of flammable liquids, gases or dust. Lawnmowers create sparks which may ignite the dust or fumes.
- Do not use the lawnmower in bad weather conditions, especially when there is a risk of lightning. This decreases the risk of being struck by lightning.
- Thoroughly inspect the area where the lawnmower is to be used and remove all stones, sticks, wires, bones, and other foreign objects. Thrown objects can cause personal injury.

Electrical safety

 Do not expose the lawnmower to rain or wet conditions. Water entering a lawnmower may increase the risk of electric shock.

Personal safety

- Use personal protective equipment. Always wear eye protection. Protective equipment will reduce personal injuries.
- **Dress properly.** Do not wear loose clothing or jewelry. Keep your hair and clothing away from moving parts. Loose clothes, jewelry or long hair can be caught in moving parts.
- While operating the lawnmower, always wear long trousers. Exposed skin increases the likelihood of injury from thrown objects.

 While operating the lawnmower, always wear non-slip and protective footwear. Do not operate the lawnmower when barefoot or wearing open sandals. This reduces the chance of injury to the feet from contact with the moving blade.

- Prevent unintentional starting. Ensure the switch is in the off-position before connecting to power source and/or batteries, picking up or carrying the lawnmower. Carrying a lawnmower with your finger on the switch or energizing a lawnmower that has the switch on invites accidents.
- Remove any adjusting key or wrench before turning the lawnmower on. A wrench or a key left attached to a rotating part of the lawnmower may result in personal injury.
- Keep proper footing and balance at all times. This enables better control of the lawnmower in unexpected situations.
- Stay alert, watch what you are doing and use common sense when
 operating a lawnmower. Do not use a lawnmower while you are tired
 or under the influence of drugs, alcohol or medication. A moment of
 inattention while operating a lawnmower may result in serious personal
 injury.
- Do not let familiarity gained from frequent use of lawnmower allow you to become complacent and ignore lawnmower safety principles.
 A careless action can cause severe injury within a fraction of a second.
- To avoid operator blade contact or a thrown object injury, stay in the operator zone behind the lawnmower handles. Blade contact or thrown objects may result in serious personal injury.
- Do not touch blades and other hazardous moving parts while they are still in motion. This reduces the risk of injury from moving parts.

Lawnmower use and care

- Use the lawnmower and accessories in accordance with these instructions, taking into account the working conditions and the work to be performed. Use of the lawnmower for operations different from those intended may result in a hazardous situation.
- Before using the lawnmower, always visually inspect to see that the blade(s) and the blade(s) assembly are properly secured and not worn or damaged. Loose, worn, or damaged parts may increase the risk of injury.
- Keep guards and other safety devices in place, properly mounted, and in working order. A guard or other safety device that is loose, damaged, or is not functioning correctly may result in personal injury.
- Keep all cooling air inlets clear of debris. Blocked air inlets and debris may result in overheating or risk of fire.
- Do not use the lawnmower if the switch does not turn it on and off.
 Any lawnmower that cannot be controlled with the switch is dangerous and must be repaired.



- Do not operate the lawnmower in wet grass. Walk, never run. This
 reduces the risk of slipping and falling which may result in personal injury.
- Do not operate the lawnmower on excessively steep slopes. This reduces the risk of loss of control, slipping and falling which may result in personal injury.
- Do not force the lawnmower. Use the correct lawnmower for your application. The correct lawnmower will do the job better and safer at the rate for which it was designed.
- Be aware of the mower and attachment discharge direction and do not point the mower discharge at anyone. Thrown objects can cause personal injury.
- Use extreme caution when reversing or pulling the lawnmower towards you. Always be aware of your surroundings. This reduces the risk of tripping during operation.
- When working on slopes, always be sure of your footing, always work across the face of slopes, never up or down and exercise extreme caution when changing direction. This reduces the risk of loss of control, slipping and falling which may result in personal injury.
- Operate the disabling device and/or remove all battery packs, if removable, from the lawnmower before making any adjustments, changing accessories, or storing the lawnmower. Such preventive safety measures reduce the risk of starting the lawnmower accidentally.
- Keep handles and grasping surfaces dry, clean and free from oil and grease. Slippery handles and grasping surfaces do not allow for safe handling and control of the lawnmower in unexpected situations.
- Check the grass catcher frequently for wear or deterioration. A worn or damaged grass catcher may increase the risk of personal injury.
- Before removing the grass catcher, turn off the motor and wait until
 the blade(s) comes to a complete stop. The cutting blade(s) continues
 to rotate after the blade control is released. Never place any part of the
 body in the blade(s) area until you are certain the motor is off and the
 blade(s) has stopped rotating. Contact with the moving cutting blade(s)
 may result in serious personal injury.
- Before unclogging the chute, turn off the motor, wait until the blade(s) comes to a complete stop, operate the disabling device and/ or remove all batteries, if removable. The cutting blade(s) continues to rotate after the blade control is released. Never place any part of the body in the blade(s) area until you are certain the motor is off and the blade(s) has stopped rotating. Contact with the moving cutting blade(s) may result in serious personal injury.
- Before cleaning or inspecting the lawnmower, turn off the motor, wait until the blade(s)comes to a complete stop, operate the disabling device and/or remove all batteries, if removable. Accidental contact with the moving blade and moving parts may result in personal injury.

Battery lawnmower use and care

- Use only with ECHO eFORCE_® 56V battery series. Use of any other batterypacks may create a risk of injury and fire.
- Recharge only with ECHO eFORCE® 56V battery series chargers. A charger that is suitable for one type of battery pack(s) may create a risk of fire when used with another battery pack(s).
- Follow all charging instructions and do not charge the battery pack(s) or lawnmower outside the temperature range specified in the instructions. Charging improperly or at temperatures outside the specified range may damage the battery and increase the risk of fire.
- Do not use a battery pack or lawnmower that is damaged or modified. Damaged or modified batteries may exhibit unpredictable behavior resulting in fire, explosion or risk of injury.
- Do not expose a battery pack(s) or lawnmower to fire or excessive temperature. Exposure to fire or temperature above 265°F(130°C) may cause explosion.
- Under abusive conditions, liquid may be ejected from the battery(ies); avoid contact. If contact accidentally occurs, flush with water. If liquid contacts eyes, additionally seek medical help. Liquid ejected from the battery(ies) may cause irritation or burns.
- When battery packs are not in use, keep them away from other metal objects, like paper clips, coins, keys, nails, screws or other small metal objects that can make a connection from one terminal to another. Shorting the battery terminals together may cause burns or a fire.

Service

- Have your lawnmower serviced by a qualified repair person using only identical replacement parts. This will ensure that the safety of the lawnmower is maintained. Use of parts which do not meet the original equipment specifications may lead to improper performance and compromise safety.






Do not damage the cable while installing the upper handle.

Install the Upper Handle

- 1. Place the mower upright in vertical position.
- 2. Remove the packing material from the cable.
- 3. Remove the rubber edge guard from the upper handle.



- 4. Insert the upper handle (3) into the lower handle (4).
- Put the bolts (25) through the holes and tighten with the nuts (26), using a screwdriver (not included).




Make sure that the two handle pins are in the same position.

Unfold the Lower Handle

1. Pull up on the handle holes (13) to release the lower handles (4).



2. Fold the lower handle up until the handle pins (P) lock into position.




Mower Functions

In general, a lawn mower is featured with three functions (rear bagging/mulching/ side discharging). These functions can be converted by changing accessory setting. Please see the following table for detail setting.



Install the Grass Catcher

- 1. Remove the battery and safety key.
- 2. Remove the mulch plug.
- 3. Remove the side discharge chute.
- 4. Open the rear discharge door and hold it.




- Hold the the grass catcher (8) by its handle and engage the hooks (14) on the door rod (15).
- 6. Close the rear discharge door.

Install the Mulch Plug

- 1. Remove the battery and safety key.
- 2. Remove the grass catcher.
- 3. Open the rear discharge door (5) and hold it.
- Hold the mulch plug (10) by its handle and fit it in the discharge chute.
- 5. Close the rear discharge door.




Install the Side Discharge Chute

WARNING

When you use the side discharge chute,

- · Do not install the grass catcher.
- Keep the mulch plug installed.
- 1. Remove the battery and safety key.
- 2. Open the side discharge door (16) and hold it.
- Line up the recesses of the side discharge chute (9) below the pivot.
- 4. Close the side discharge door.




Set the Cutting Height

The machine can be set to different cutting heights.

- Pull the height adjustment lever (6) rearward to increase the cutting height.
- 2. Pull the height adjustment lever forward to decrease the cutting height.

Installing and Removing the Battery

NOTICE

The machine has an automatic switch function that lets the other battery work when the first cannot operate.


The battery comes partially charged from the factory and needs to be fully charged before first use.

Note: See separate Operator's Manual Packaged with the Battery.

Installing the Battery


- 1. Lift and hold up the battery door (17).
- 2. Align the battery with the mower's battery port.
- Make sure the battery release button (18) snaps in place and that battery is fully seated and secure in the mower before beginning operation.
- 4. Insert the safety key (19).
- 5. Close the battery door.

Note: The machine has an automatic switch function that lets the other battery work when the first cannot operate. Extra battery can be purchased from dealer.



Removing the Battery

- 1. Stop the machine.
- 2. Open the battery door (17).
- 3. Remove the safety key (19).
- Press the battery release button (18) on the mower. This will cause the battery to raise out of the tool slightly.
- 5. Remove battery from the product.



Starting the unit


WARNING

When starting the unit, observe the precautions described in the "Safety" section. Failure to observe the precautions could cause an accident or injury, or even lead to a fatality.

Wait until the blade fully stops before you start the machine again. Do not quickly turn the machine off and on.

- Make sure safety key is inserted into slot.
- 2. Push and hold the start button (1).
- While you hold the start button

 (1), grab the start handle (2) in the direction of the handle bar.
- 4. Once the machine has started, you can release the start button.
- 5. Press Turbo button (20) to speed up.
- 6. Press LED light button (21) to turn on the LED headlights.



Stopping the unit

Release the start handle to stop the machine.

Note: Always remove the safety key and battery after you complete the work.


Self-Propel Drive System

- 1. Start the machine.
- While you hold the start handles

 (2), grab either of the drive levers
 (11) and pull towards the handle bar
- Hold the start handles and the drive levers at the same time.
- Release either set of start handle (2) and drive lever (11) from the same side.
- 5. Adjust the speed control (22) with your free hand.
 - Slide the speed control button in the direction of the Rabbit Symbol to increase the speed.
 - Pull the speed control button in the direction of the Turtle Symbol to decrease the speed.
- 6. Release the drive levers to disengage the self-propel system.

To engage the self-propel drive system while the mower is not running:

 Press and hold the start button (1), then pull up on the drive lever (11) or pull up on the drive lever (11), then press the start button (1).



Operate on Slopes


WARNING

Do not mow on the slopes with incline more than 15 degrees. If you are not comfortable, do not mow on a slope. Please keep a low self-propelled speed when you mow on a slope.

- Do not go up and down on a slope, mow across the face of the slope. Be careful when you change the direction on a slope.
- Monitor the holes, ruts, rocks, and other hidden objects that can cause you to fall. Remove all obstacles such as rocks and tree limbs.
- Make sure that your footing is stable. If you are out of balance, release the start handle immediately.
- Do not mow near drop-offs, ditches, or embankments.

Empty the Grass Catcher

- 1. Stop the machine.
- 2. Remove the safety key.
- Remove the battery.
- 4. Open the rear discharge door and hold it.
- 5. Hold the grass catcher by its handle and unhook it from the door rod.
- 6. Close the rear discharge door.
- 7. Empty the grass catcher.

Operation Tips

- Do not try to override the operation of the start button or start handles.
- Do not tilt the machine when you start it.
- Do not put hands or feet near or below the turning parts.
- · Keep the discharge chute clean.
- Cut wet grass will require more power and shorten run time.
- Higher blade height is necessary for new or thick grass.
- Clean the bottom of the mower deck after each use. Remove grass clippings, leaves, dirt, and other debris.

MAINTENANCE

WARNING

Moving parts can amputate fingers or cause severe injuries. Keep hands, clothing and loose objects away from all openings. Always stop motor, and make sure all moving parts have come to a complete stop before removing obstructions, clearing debris, or servicing unit. Allow unit to cool before performing service. Wear gloves to protect hands from sharp edges and hot surfaces.

WARNING

Operating a poorly maintained unit can result in serious injuries to operator or bystanders. Always follow all maintenance instructions as written, otherwise serious personal injury can result.

Your unit is designed to provide many hours of trouble free service. Regular scheduled maintenance will help your unit achieve that goal. If you are unsure or are not equipped with the necessary tools, we recommend that you take your unit to a Servicing Dealer for maintenance. To help you decide whether you want to DO-IT-YOURSELF or have the Dealer do it, each maintenance task has been graded. If the task is not listed, see your Dealer for repairs.


Cleaning Battery and Battery Compartment



Remove the safety key and battery from the machine before maintenance.


- 1. Open the battery door (17).
- Depress battery release button (18) and slide battery out of battery compartment.

 Use compressed air or a soft bristle brush to remove debris from battery and battery compartment (23).





Replace The Blade


WARNING

Use only approved replacement blades. Wear heavy gloves or wind cloth around the blade when you touch the blade.

- 1. Stop the machine.
- 2. Make sure that the blade fully stops.
- 3. Remove the safety key and batteries.
- 4. Turn the machine to its side.
- Use a piece of wood or special lawnmower blade holding tool to prevent the movement of the blade.
- Remove the mounting bolt (26) and spacer (25) with a wrench or socket.
- 7. Carefully detach the blade (24), fan (28) and base (27).
- 8. Inspect the fan, blade bolt, and base for any damage.
- Install the new blades following the specified sequence: base, fan, blade, spacer, and mounting bolt. Make sure the arrows on the fan engage the holes on the blade.
- Securely tighten the blade bolt. Recommended tightening torque: 33-37 Nm.

Apply Loctite # 242 or equivalent to bolt threads each time blade is removed and reinstalled.




